


## **Assembly Instructions**

#### **WARNING**


- FOR OUTDOOR USE ONLY! NEVER LEAVE A FIRE UNATTENDED!
- DO NOT burn over 6 lbs. untreated wood or fire logs in this fire pit.
- DO NOT allow children or pets near fire pit without supervision.
- DO NOT touch the surface of the fire pit while in use as it may cause burns.
- NEVER burn in vehicles, tents or indoors. CARBON MONOXIDE HAZARD.
- Use a poker and/or heat-resistant gloves to open/close the mesh cover while in use.
- DO NOT use water to extinguish as this is dangerous and can cause damage to the fire pit.
- Burn only untreated wood or fire logs in this fire pit.
- DO NOT use gasoline or kerosene to start the fire in this fire pit.
- DO NOT use this unit on a wood deck , long or dry grass and/or leaves, or on combustile surfaces
- DO NOT attempt to move the fire pit while it is hot or in use.






#### Step 1:

Insert Poker Bracket (A) into hole in mesh cover (B) and secure with M6 nut (BB). Tighten nut with wrench (DD)




### Step 2:

Place fire bowl (E) on its side on a smooth, clean surface. Attach one air vent (D) by inserting two M6 x 12mm bolts (AA) through pre-drilled holes in firebowl (E) and air vents (D) as illustrated. Repeat with remaining air vents (D). Tighten all bolts with a screwdriver.




# Step 3:

Attach Legs (F and G) to the fire bowl (E) by inserting M6 x 12mm bolts (AA) through pre-drilled holes in firebowl (E) and legs (F and G) as illustrated. Tighten all bolts with a screwdriver.




### Step 4:

Insert the threaded pegs (CC) into the fire bowl(E) as illustrated and hand tighten.




#### Step 5:

For fire pit use, top with mesh cover (B). Place poker (H) beside fire pit for use as needed.



## Step 6:

For barbeque use, remove mesh cover (B), place cooking grid (C) onto the threaded pegs in the bowl. Replace mesh cover (B) when fire is lit and food is placed on the cooking grid.
